You have to submit the following documents in original and (07) Seven without attest photocopies of each with the college office before depositing the college fee.

1. Secondary School Certificate (Matric/equivalent Certificate).
2. Certificate/detailed marks certificate of F.Sc (pre-medical / equivalent along with school certificates).
3. Provisional Certificate / Character certificate of college last attended.
4. Result card of Entry Test by UHS Lahore.
5. Domicile Certificate.
6. Copy of CNIC / B-Form.
7. Copy of CNIC (Father / Guardian).
8. Hafiz-e-Quran certificate (if applicable).
9. Board Migration Certificate/N.O.C from concerned Board in favor of U.H.S, Lahore, in case the Board of F.Sc./Equivalence is other than province of Punjab.
10. Birth certificate if date of birth is not available on Matric certificate/equivalent certificate.
11. Twenty (20) passport size photographs without attested (sky blue background).
12. You will be medically examined by a board of doctors as a part of your admission process. The candidates must produce certificates.
 - (a) That you have been inoculated against the enteric group of fevers within the preceding 12 months.
 - (b) That you have been fully vaccinated against Tetanus.
 - (c) That you have had a full course of immunization against Hepatitis "B" Virus.
13. College Fee amounting to Rs. 48085/- & Hostel Fee Amounting to Rs. 41140/- (for the session 2020-2021).
14. Additional dues will be charged, if boarder wants to avail the facility of following electric appliances, as per rates approved by this office. Proper prior permission for installation is required.

Students has to submit a Surety Bond worth rupees Three (03) million stating that he/she would serve Government of the Punjab, Health Department as "Probationary Medical Officer/Women Medical Officer" in the primary healthcare facilities for a period of one year after completing the foundation year/house job. In case he/she fails to fulfill the commitment, he/she shall be liable to pay Rs. Three (03) million to the Government." (Health Department Notification No. S.O. (ME) 9-4/2016 dated 24 August 2016) on a stamp paper worth Rs. 100/- duly attested by the first class magistrate (Specimen of which is enclosed).

17. An undertaking by the student and his/her Parents / Guardian on stamp paper worth Rs. 100/- duly attested by the first class Magistrate, stating that if found guilty the student will be expelled from the college without any notice on joining any political party/group and will strictly abide the college discipline/rules.

18. Your eligibility for admission is subject to verification of your documents/certificates from issuing authority. Your admission is liable to be cancelled at any time during the course of study if any of your documents, certificates or statement is found wrong in any way at any stage. Admission is also liable to be cancelled/changed if any error or omission is detected at any stage.

19. A part from this, all the rules and regulations, contained in the Prospectus of the Govt. Medical Institutions of the Punjab session 2020-21 and changes from time to time, are applicable and these will be binding upon you.
