The Meeting was started with recitation from the Holy Quran. The chairman welcomes all the participants and briefed about proceeding of this meeting and then the



Medical Superintendent briefed about advertised specification and ask for reservation, objections if any. Adequate time was given to the representative from different companies and their minor queries which were pointed out were answered.

The above mentioned firms submitted their queries / reservations regarding following.

- The representative of M/S Meditech Instrument brief the committee that ABGs analyzer of its is not facilitated with Serum Lactat test, while rest of the test demanded by Allama Iqbal Teaching Hospital, D.G. Khan in ABGs Tender are available. The end user Dr. Abrar Hussain Incharge Central ICU asked about for Serum magnesium, Serum Calcium and chloride. The representative of M/S Meditech informed that Serum Magnesium has not been advertised by the parent procuring agency, while serum calcium and chloride are available as optional. He also added that the reagents pack of ABGs analyzer of M/S Meditech is more cheaper and is functional in many well known government institute, he also ensured that for serum lactate an additional facility will be provided. The committee unanimously decide that the technical evaluation committee alongwith end user should be decide either the additional facility of the serum lactate test accepted or not during technical evaluation committee also decided that available for ABGs Analyzer only compatible reagents will be accepted as this ABGs Analyzer is hospital own property, and cannot be treated for rental base contract.
- The representative of the M/S Mednostic Healthcare Karachi briefed the committee that Surgical Disinfectant Scruo CHX 4% has not been included in list for F.Y 2024-25, he quoted its additional benefits and its availability in different institute of the Punjab. The chair asked about this from the hospital pharmacist and it has been informed to the committee the said product has not been demanded by any of the end user for F.Y. 2024-25 and its substitute povidone iodine scrub is part of the hospital formulary approved by the P&T Committee also. After detail discussion it has been decided that the salt should be circulated to the end users for evaluation for future.
- The M/S Optisurge quoted that the specification advertised in Surgical Disposable OTs list for Sr. No. 64 & 85 are not correct. The same has been confirmed from the concerned end user demand submitted by him for F.Y 2024-25 and it has been noticed that advertised specification does not match with the end user demand. So the committee decided that it should be published according to the demand of the Head of the Ophthalmology department, which is as under

Sr. No.64. Posterior chamber, multipiece preloaded Hydrophobic foidable intra ocular lens can be impalanted trough 2.2ml incision

Sr. No. 85. copolymer metrial (hydrophilic inward and hydrophobic outworld ) preloaded single piece aspheric optic can implant with 2.2 to 2.4mm

- The advertised of Medicines Injectable Sr. No. 138 & Sr. No. 177 are exactly same and, so it has been unanimously decided and as per demand from the end user and last year consumption the Sr. No. 138 is for adult dose and 2.25g should be replaced with 4.5G.
- Keeping in view the current year issue of X-Ray Machines and films, it has been decided that it is mandatory to demand compatible CR System on placement / rental basis (as per hospital demand) with digital printer with digital films as already advertised. So the firm which is participated in the tender of X-Ray / C.T. Scan films will bound to provide the CR System on placement / rental basis (as per hospital demand) with digital printer digital films as advertised with free of cost maintenance.
- It has been decided to publish decisions of this meeting on medical college website www.dgkmc.edu.pk.
